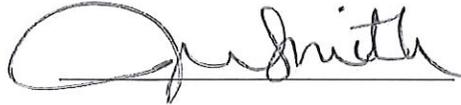

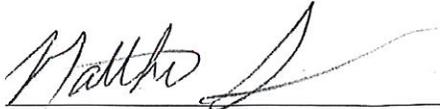
1. Crossgates Mall Road
